#### NEWS YOU CAN USE—SHORT TERM RENTALS

Every RPENA resident remembers the signs bringing attention to the plight of STRs (short-term rentals). The Dallas city Council voted to ban short-term rental properties from single-family residential neighborhoods in a 12-3 vote. The council also implemented a registration requirement, and will implement fees like a hotel tax on STRs. In addition to the fees, new rules require that properties have off-street parking, and must adhere to the city's noise limits. The rules went into effect immediately, but enforcement doesn't start until December 14.

According to the Dallas Sort-Term Rental Alliance website (a vocal opponent of the measure banning them), have a campaign to raise money and in a press release, they announced they have hired Lynn Pinker Hurst Schwegmann to sue the City of Dallas. Then on 10/2/2023, the law firm filed the official application for temporary injunction (https://s3.documentcloud.org/documents/24003460/dallas-short-term-rental-alliance-lawsuit.pdf). The address takes you to a copy of the injunction.


Recently, Community Impact of the Lake Highlands Lakewood Association ran a story about a retired couple who planned on continuing to rent out their converted garage attached to their home which serves as retirement income supplement of about \$16,000 annually. They have elected to join the opponents of the new rules because they claim they will not be able to operate under the new rules.

Regardless of where you stand, it is important to know all you can about the issue. Estimates range in the number of STRs. City Hall estimates that there are more about 5,000 STRs operating in Dallas (Airdna.co estimates there are 5,517). Some operate in the city's conservation or planned development districts. Using data from City of Dallas, there are 1800 registered under the new ordinance, about 1300 are not registered.

#### CARAMEL CANDY HOT TODDY (COURTESY OF SPECS)

#### Ingredients

- 6 oz bourbon
- 1/2 cup caramel
- 2 cup water
- Werther's Original Candies
- 1/3 cup lemon juice
- 2 cinnamon sticks
- Lemon slices for garnish

#### Directions:

Crush candies in a plastic bag and place on a plate, also add the caramel to another plate. In a small saucepan over medium heat, combine water, 4 Werther's and cinnamon sticks. # REMINDER ON COMMERCIAL VEHICLES IN THE NEIGHBORHOOD

A person commits an offense if he stops, parks, or stands a truck-tractor, road tractor, trailer, semitrailer, pole trailer, bus, or any commercial motor vehicle upon a public street, alley, parkway, boulevard, or public place. This section shall not apply to street construction, maintenance, and repair equipment; trucks, equipment, trailers, and vehicles used by public service utility companies engaged in repairing or extending public service utilities; motor busses when taking on or discharging passengers at customary bus stops; other vehicles when actually parked at a designated loading zone, or where it is

lawful to park a commercial motor vehicle for the purpose of accepting or delivering transportable goods; or a vehicle with a mechanical defect, making it unsafe to proceed further, in which event, it shall be lawful to stand or park the vehicle during the time necessary to make emergency

# PET CORNER: PUMKIN PET TREATS

If you happen to have left over canned pumpkin, this is a must treat to the 4 legged family members (cats like this too). Please know what your pet can eat. This has a few gross ingredients.

#### Ingredients

- 2 1/2 Cups Whole Wheat Flour
- · 1/2 Cup Canned Pumpkin
- · 2 Eggs
- 4 Ounces Chicken Livers
- · 2 Tbsp Peanut Butter
- · 1/2 Tsp Salt

Process: Please pumpkin, eggs, chicken livers peanut butter and salt in a blender. Process until smooth, then pour out into a bowl with flour. With heavy spatula or use gloves mix until it stops being sticky. You can then roll this out flat onto a well greased baking pan and using a knife, cut lines into he dough. If you are experienced, use cookie cutters to cut into shapes. Bake at 350 degrees for 30 minutes. Watch your pan to make sure you don't burn them. Take them to the hardness of your choice for your pet.
